

COMMISSIONERS PROCEEDINGS

Madison, Nebraska

December 22, 2008

The Board of County Commissioners of Madison County, Nebraska met in regular session at 2:00 P.M.

Advance notice of meeting was published in the Wednesday, December 17, 2008 edition of The Norfolk Daily News. A copy of said notice was mailed to each Board member. An affidavit of acknowledgment of receipt of notice of meeting as published was executed. Chairman Jerry McCallum called the meeting to order and notified the public of the location of the information regarding the Open Meeting Act posted in the meeting room.

Present: Commissioners Jerry McCallum, Rick Uhlir, and Lee Klein, County Highway Superintendent Richard Johnson, and County Clerk Nancy Scheer.

Chairman McCallum read the following consent agenda items into the record:

RESOLUTION #2008-76

WHEREAS, Check No. 11080174, dated November 12, 2008, and drawn on the General Fund in the amount of forty dollars (\$40.00), was made payable to Shoppers Express, 810 Norfolk Avenue, Norfolk, Nebraska 68701, and

WHEREAS, said check was not tendered, but remains in the possession of the Madison County Clerk,

NOW, THEREFORE, BE IT RESOLVED that Check No. 11080174, dated November 12, 2008, and drawn on the General Fund in the amount of forty dollars (\$40.00), is hereby cancelled.

Pursuant to published legal notice in the Monday, December 15, 2008 edition of The Norfolk Daily News, Chairman McCallum opened a public hearing at 2:30 P.M. to receive citizens' comments regarding a proposal to amend the 2008-2009 fiscal year county budget. County Clerk Nancy Scheer explained that Madison County is eligible to receive enhancement grant funds in the amount of \$9,514 from the Nebraska Crime Commission to fund expenditures in the Juvenile Diversion office. She reported that the county must provide matching funds in the amount of \$3,805 and that funds are available in the Miscellaneous General office function of the General Fund to transfer to the Juvenile Diversion office function. In addition, she reported that the proposed amendment to the Juvenile Diversion office function would have no effect on the 2008-2009 fiscal year property taxes.

No comments were received from the public. Chairman McCallum closed the public hearing at 2:34 P.M.

After discussion, the following resolution was introduced:

RESOLUTION #2008-77

WHEREAS, Madison County is eligible to receive enhancement grant funds in the amount of \$9,514.00 from the Nebraska Crime Commission during the 2008-2009 fiscal year, and

WHEREAS, receipt of said funds was not anticipated during preparation of the 2008-2009 fiscal year budget, and

WHEREAS, said receipts, along with county matching funds in the amount of \$3,805.00, will fund additional expenditures in the Juvenile Diversion office function of the General Fund, and

WHEREAS, it is anticipated that additional appropriations of \$13,319.00 will be necessary to provide for the expenditure of the grant funds received for the remainder of the 2008-2009 fiscal year, and

WHEREAS, the county has cash on hand to transfer from the Miscellaneous General office function in the General Fund for the required county match, and

WHEREAS, additional appropriations in the Juvenile Diversion office budget will have no effect on budgeted property taxes, and

WHEREAS, a duly advertised public hearing was held as required by Section 13-511 Nebraska Revised Statutes,

NOW, THEREFORE, BE IT RESOLVED, that additional budget authority in the amount of \$13,319.00 is hereby granted to the Juvenile Diversion office function of the General Fund; and

BE IT FURTHER RESOLVED, that the 2008-2009 fiscal year budget is hereby amended to reflect additional receipts of \$9,514.00 in the General Fund and additional expenditures of \$13,319 in the Juvenile Diversion office function of the General Fund as stated herein, and

BE IT FURTHER RESOLVED, that additional budget authority in the amount of \$3,805.00 is hereby allocated to the Juvenile Diversion office function from the Miscellaneous General office function of the General Fund.

Motion was made by Klein and seconded by Uhlir that the foregoing resolution be adopted. Roll call vote: Ayes, McCallum, Uhlir, and Klein. Nays, none. Motion carried.
